IPC's Educational Initiatives

The office of the Ontario Information and Privacy Commissioner (IPC) was created to provide an independent review of the decisions and practices of provincial and municipal government organizations concerning access and privacy.

One of its key mandates is to help Ontarians understand their rights under the Freedom of Information and Protection of Privacy Act and the Municipal Freedom of Information and Protection of Privacy Act.

As well as an extensive publishing program, an informative Web site, specialized teacher's kits for Grade 5 social studies teachers, Grade 10 civics teachers and Grade 11 and 12 law teachers across the province, the IPC has a variety of speaking programs.

Under its *Reaching Out to Ontario* program, the IPC sends a team of speakers to several different regions of Ontario each year. The 2002 *Windsor and Area Educational Initiative* is the 10th such program.

One of the focal points of this trip will be a **public information session** at the central branch of Windsor Public Library (850 Ouellette Ave.) at 7 p.m., Thursday, May 16. An IPC team will briefly outline Ontario's provincial and municipal Freedom of Information and Protection of Privacy legislation, explain the IPC's role as an oversight agency, and outline your right to access government information and your right to have your privacy protected.
