The Pediatric Oncology Group of Ontario (POGO) is pleased to submit its report for the review period 2014-2017, in compliance with the *Manual for the Review and Approval of Prescribed Persons and Prescribed Entities*, issued by your office on April 19, 2010.

We have also included Dr. Corin Greenberg's signed and notarized affidavit.

We would like to thank Ms Judith Goldstein, Legal Counsel, and Ms. Nicole Minutti Health Privacy Policy Analyst from your office for their assistance in clarifying questions pertaining to the manual. A special thank you is given to POGO Senior Management, the POGO Information Technology Team, and to Ms. Dina Skvirsky (our Administrative Assistant) for all their assistance in writing, editing, reviewing and preparing this report.

In compliance with recommendations made by the IPC after your last review period in 2013/14, POGO has: developed and implemented a fulsome Business Continuity Plan; updated its privacy and security audit documentation and processes; augmented its privacy impact assessments to ensure all information required by the Manual has been included; and ensured that the privacy and security audit indicators also reflect the requirements outlined in the manual.

As discussed and agreed to at the time of the last review, we will post Parts 1 to 4 of the Report and the Sworn Affidavit. Given the sensitivity of the information contained in Appendix 1: Privacy, Security and Other Indicators, POGO will not post this appendix on its website. POGO feels that the information contained in this document could potentially adversely impact our information security safeguards, if published. We would respectfully request that when we are ready to make our Privacy Report public, we will provide a version of Appendix 1 that is suitable for posting on the IPC website.

We remain confident that POGO's status will be renewed and look forward to your response.
